This resolution request is a zero-dollar purchase agreement for thirteen (13) tandem dump truck bodies and two (2) street sweeper bodies to support DOTI’s Street Maintenance Division. These bodies will be assembled onto Freightliner cab and chassis. To finance this and seven other zero-dollar purchase agreements, there is a capital lease agreement being submitted simultaneously. The total cost of all equipment under this zero-dollar purchase agreement with OJ Wastson will be \$2,147,422.71. The total principal on the capital lease agreement is not to exceed \$21,250,000.
