A BILL

For an ordinance authorizing a capital equipment purchase from the Golf Enterprise Fund (79100).

WHEREAS, the Department of Parks and Recreation (DPR) is seeking approval for a capital equipment purchase of a sprayer to support operations at the Willis Case Golf course; and

WHEREAS, said purchase has become a high-priority and will be made in place of the greens mower that was approved in the Annual Appropriation Ordinance, 1539, Series of 2024; and

WHEREAS, said purchase will be authorized from the Golf Enterprise Fund (79100); and

WHEREAS, the cost of the sprayer is over the \$50,000 threshold for capital equipment items that require City Council approval, per the Denver Revised Municipal Code;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the Golf Enterprise Fund Series (Accounting No. 79000) the Executive Director of the Department of Parks and Recreation, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:

Section 2. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
