The purpose of this Amendment is to extend the term of this Professional Design Services Agreement by two years, to January 3, 2023. Capacity of the contract will be increased from \$791,769.33 to \$1,191,631.97. Now that design of this bridge is nearing completion, this Amendment is needed to provide professional engineering and related services during construction of the replacement bridge which will carry W. 8th Ave. over the S. Platte River. The RFQ for this Contract stated that Professional Services during construction would eventually be requested from the selected firm.

Replace an 89-year-old bridge which has far exceeded its initial life expectancy. The bridge serves as an important transportation link to and from Interstate 25 for critical local truck access to nearby industrial uses.
