  - No charge for travel within the greater Las Vegas, Nevada metropolitan area
  - Travel time outside of the above-listed metropolitan areas is prorated at \$200.00 per hour
  - Actual cost of all reasonable and necessary travel expenses, including airfare, hotel, parking, ground transportation, mileage (IRS rate), and meals
- ❖ Cancellation & Postponement Fees:
  - Half Per Diem Fee of \$800.00 for each day of hearing cancelled with thirty (30) days or less notice, along with any non-refundable expenses incurred
  - Per Diem Fee of \$1,600.00 for each day of hearing cancelled with fifteen (15) days or less notice, along with any non-refundable expenses incurred
