**A BILL**

**For an ordinance making rescissions, cash transfers and supplemental appropriations from the General Contingency Fund to Departments;**

**WHEREAS**, the Hearing Office needs a budget adjustment for an unbudgeted retirement payout; and

**WHEREAS**, the Department of Finance-Real Estate Capital Projects needs a budget adjustment for renovations at the 48<sup>th</sup> Avenue Shelter, and Denver Human Services will transfer \$1,400,000 for this project; and

**WHEREAS**, the Office of Economic Development needs a budget adjustment to cover Aerotropolis marketing as part of a cooperative agreement with Denver International Airport and Adams County; and

**WHEREAS**, the Office of the Municipal Public Defender needs a budget adjustment to address increasing criminal investigations, legal counsel needs and interpreter service caseloads; and

**WHEREAS**, the District Attorney needs a budget adjustment to offset unbudgeted retirement payouts;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
