The purpose of the Old South Gaylord Business Improvement District is the maintenance of the 1000 block of South Gaylord Street. The street is comprised of retail shops, restaurants, and professional offices.

- 1 The total landscaping expenses budgets are \$6810. We continue to have long term relationships with our vendors. MTL Services provides the lawn care and leaf clean up services. Uncommon Ground is our gardener and provides planting in tree beds, gardens, and planters.
- 2 The street directory is published annually by Joyce Bickel for \$500 plus printing.
- 3 Accounting services are provided by Dianne Zezulak for a fee of \$100 monthly.
- 4 Our insurance carrier is the Colorado Special District Property and Liability Pool and is based on last year's premium.
- 5 Snow removal is provided by MTL Services and varies greatly each year by the amount of snowfall.
- 6 The professional dues are paid to the Special Districts Association and are based on the 2010 dues.
- 7 Colorado Cascade provides then sprinkler sysem maintenance and repair. The amount budgeted is based on normal spring repairs when system is seasonally turned off and on.
- 8 The electrical outlets in the tree beds are maintained at approx \$200 annually.
- 9 Sidewalk cleaning will be done annually.
- 10 The BID will pay for half of the cost of the tree lights for the street for the year. The company handling the light installation and upkeep is Holiday Decoratios, Inc. The Merchant's Association will pay the other half of the expense.

The Old South Gaylord Business Improvement District uses a cash basis accounting system. The district has no debt obligations.

The 2010 Budget vs Actual was prepared on September 3, 2010. The final quarter of 2010 is an estimate.

The overall Landscaping expenses for 2010 stayed within budget, including the decorative tree lighting and monies budgeted for outdoor flowers in the tree beds.

The Maintenance and Repair dollars spent in 2010 went over budgeted amount due to the following:

Miscellaneous expense of \$500 spent on concrete repair.

Sidewalks were power washed after not havily ving been cleaned for several years 2011 budget reflects upkeep annually.

Snow removal budget falls around \$5000 each year, varying with the snowfall each year. Snow removal 1st half of 2010 was 60% of budget and estimated actual will exceed budget by \$1000. This adjustment has been made for the 2011 Budget.

Sprinkler system repair and maintenance exceeded budget due to a zone replacement/repair in June of 2010. This is a carryover from the new sprinkler system from 2009.

Utility expense exceeded 2010 budget as the BID discovered that the water line for the street had been previously billed to another account on S Gaylord S Street for many years prior. These monies were paid for and reimbursed to the Two Five to the Two One Zero Radial Company. Denver Water has since been billing the Improvement District correctly and the 2011 budget reflects this.

Monies to properly address these maintenance and repair issues for South Gaylord Street were taken out of the reserve fund.
