9 **For an ordinance approving and providing for the execution of a proposed**
10 **contract between the City and County of Denver and the State of Colorado**
11 **concerning the "Community Corrections FY18-19" program and the funding**
12 **therefor.**

14 **WHEREAS**, the State of Colorado, Department of Public Safety, Division of Criminal Justice,
15 has notified the City of funding allocations for Fiscal Year 2018-2019 for Community Corrections
16 services under a contractual agreement with the City, a copy of which is duly filed with the Clerk
17 and Recorder, Filing No. 14-0157;

18 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
19 **DENVER:**

20 **Section 1.** The proposed Allocation Letter #5 for Original Contract CMS No. 68057, between
21 the State of Colorado and the City and County of Denver, a copy of which is duly filed with the City
22 Clerk, Filing No. 2018-42827, be and hereby are approved in all respects.

24 **Section 2.** The payments made by the State of Colorado to the City pursuant to and under
25 the Contracts shall be deposited into the Treasury of the City and credited to Special Fund
26 No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the
27 City and County of Denver.

29 **Section 3.** That it be and is hereby found and determined that the budget summary of said
30 "Community Corrections FY18-19" program, Accounting No. 12302-3501100 is as follows, to be
31 expended by the Executive Director of Safety:

32 State of Colorado \$17,472,090.96

34 Authorization for expenditure of said funds following execution of said contracts will cover the
35 period from July 1, 2018 to June 30, 2019.

1 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be
3 necessary to accomplish the purposes of this Ordinance.
