This amendment will add \$1,000,000 from UDFCD and the City will provide additional matching funds of \$7,400,000 (total City matching funds of \$8,200,000) bringing total contract to \$10,000,000. Agreement will fund final design, Right-of-way Acquisition and drainage and flood control improvements along Sanderson Gulch, Lipan St to the South Platte River. These funds will be held by Urban Drainage and used for design until design is complete. Any remaining funds will be remitted to the City for construction costs.
