WHEREAS, the parties hereto desire to amend the Existing Agreement as hereinafter provided;


NOW, THEREFORE, the Existing Agreement is modified as set forth herein.


- 1. The attached Exhibit C-2 hereto, replaces the Existing Agreement Exhibit C-1 effective May 1, 2010 in its entirety:

- This Second Amendment to Agreement shall not be effective or binding on the City until approved by the Denver City Council and fully executed by all signatories of the City and County of Denver.


