EXECUTIVE SUMMARY

Denver Health and Hospital Authority – Second Amendment to Lease Agreement for Office of Medical Examiner at 500 Quivas Street

This Second Amendment to Lease Agreement with Denver Health and Hospital Authority, as Landlord, is for the building located at 500 N Quivas Street occupied by the Office of the Medical Examiner.

The purpose of this amendment is to correct and restate the maximum contract amount. The original contract was drafted with the intent of reconciling the maximum contract amount based upon actual cost of construction. This Second Amendment reconciles the start of rent payments in 2016 and payment of operating expenses in 2018 when the OME first occupied the space.

The resulting corrected maximum contract amount is \$14,454,711.63.
