**Contract Overview**

The Scope of Work for these contracts shall be for task-order-based, on-call general construction services related to various construction projects within Denver International Airport (DEN), including facility upgrades, infrastructure improvements, renovations, and other construction-related tasks. The general construction contractor will provide comprehensive construction services to address the diverse needs of DEN. Execution of services and task orders to ensure project completion may include various delivery mechanisms including but not restricted to design-bid-build (DBB), design-build (DB), Construction Management at Risk (CMAR)/Construction Manager/General Contractor (CM/GC), progressive design-build, and others.

Services performed under this contract include Construction and Renovation, Pre-construction Planning, Design-Build Participation, Subcontractor Management, Quality Control, Safety Management, Construction Updates and Meetings.

These contracts will utilize individual task orders for construction or construction related work, which may include but are not limited to Facility Upgrades and Renovations, Infrastructure Improvements, New Construction Projects, Pre-construction and Planning Tasks, and Project Management and Administration.

Each contract will be for a maximum capacity of \$25,000,000 with a term of 3 years with two one-year options to extend.
