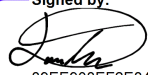

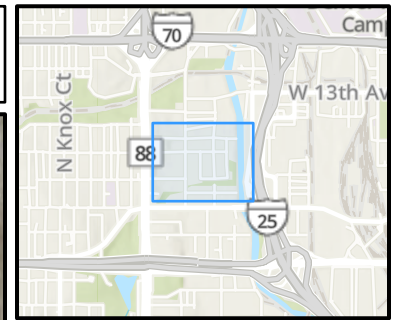

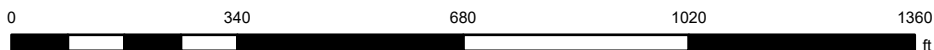

No separate bill of sale with respect to improvements on the Property will be executed.

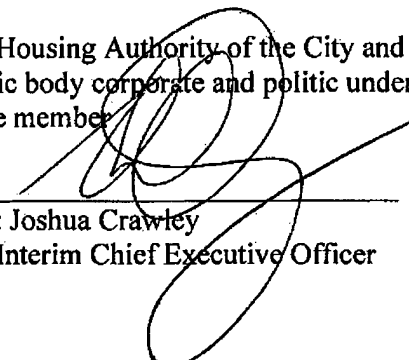
