1. Amend Ordinance Number 426, Series of 2007 to reallocate project funds within existing Better Denver Bond Program projects. To name and fund five (5) new bond projects. To modify the name of three (3) existing bond projects for clarification of scope.
2. Purpose 2 Deferred Maintenance of Cultural Facilities
  - o Change name of "Champa St. side studio space and rehearsal lofts" to "Champa St. side studio space and rehearsal lofts and DPAC Deferred Maintenance"
3. Purpose 3 – Health and Human Services

  - o Stapleton Rec Center – Reduce by \$375,000 (Central Park Rec Center)
  - o Restroom Rehab – Reduce by \$50,000

- o Ruby Hill Park – Add \$400,000

  - o Fire Station Renovations – Reduce by \$180,000
  - o PTO Firing Range – Reduce by \$850,000
