Construction services for the South Worldport Lot (Longs Peak Shuttle Lot Relocation) project at Denver International Airport (DEN). This project is in direct support of enabling the construction of a Consolidated Rental Car Facility (ConRAC) at DEN and will relocate the current Longs Peak Shuttle Lot. Additionally, the construction of this parking lot will facilitate the relocation of the Airside Employee Lot to the current Longs Peak Shuttle Lot, which aids in maintaining low shuttle times for employees and reducing congestion of passenger shuttle traffic to the surrounding rental car operations and the future ConRAC facility. Relocating the Longs Peak Shuttle Lot to create space for the ConRAC facility will contribute to DEN's goal of growing its infrastructure while improving the customer experience and increasing operational excellence. The duration of this contract is 430 calendar days.

Scope of work: The South Worldport Lot (Longs Peak Shuttle Lot Relocation) project proposes to construct a new surface parking lot that will provide approximately 5,200 parking spaces. The project site exists just south of the existing Worldport Facility between Jackson Gap St and the Pikes Peak Shuttle Lot, at Denver International Airport (DEN). The current condition of the project site is undeveloped farmland. The project proposes to develop this land and provide a new location for the Longs Peak Shuttle Lot in effort to enable the construction of a ConRAC facility. The South Worldport Lot will provide connectivity to Jackson Gap St and the N Elk St. The construction scope will include, but is not limited to earthwork and grading, stormwater drainage and conveyance infrastructure, concrete paving, construction of shuttle shelters, electrical and lighting infrastructure, electrical vehicle charging infrastructure, water service improvements and hydrants, communications and access control infrastructure, a new signalized intersection, asphalt roadway extension and widening of N Elk St, widening of Jackson Gap St, signage and pavement marking, erosion and sediment control measures, and existing roadway tie-ins
