- Led and implemented a reorganization of the Cash and Capital Funding Division aimed at the integrating, streamlining and creating efficiencies of business processes. Specific actions involved extensive stakeholder outreach plan, comprehensive review of all job classifications and compensation structures and extensive communications and input plan with CCF team.

### Managing Director of Capital Funding

Primary responsibilities include administration and management of City and Enterprise debt portfolios, currently valued at approximately \$8 billion plus derivative obligations totaling an additional \$1.8 billion. Key functions include providing

leadership, structuring, execution, investor relations and post-issuance compliance of capital financing transactions. Duties also include assisting in citywide capital planning efforts, strategic planning and department policy formulation.

**Key Achievements:**

- Led and implemented various risk mitigation and recovery efforts aimed at preserving the City's fiscal health to address challenges brought on by COVID pandemic. Actions included structuring complex financings: DEN 2020 debt restructure and reserve release, acceleration of G.O. and excise tax bonds including excise tax reserve release, liquidity facility procurement and creation of portfolios' risk assessment register. Directed ratings assessment highlighting financial management actions of leadership that resulted in preservation of credit ratings for the City.
- Developed and led professional consultant procurement and innovative citywide project evaluation process for Public Private Partnership's (P3). Implemented best practices approach to project evaluation with focus on preserving internal financial controls and prudent financial management.
- Serve as active DERP board member and add value by sharing knowledge of Denver politics and municipal finance technical competencies. Active contributor in the development, implementation and oversight of multi-year strategic plan and investment allocation strategies. Supported structural plan changes aimed at improving the long-term sustainability of plan assets.
