4 **A RESOLUTION**

5 **Approving and providing for the execution of a proposed Grant Agreement**
6 **between the City and County of Denver and the United States of America**
7 **Department of Housing and Urban Development concerning the “Housing**
8 **Opportunities for People with AIDS (HOPWA) FY21” program and the funding**
9 **therefor.**

11 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
12 Grant Agreement;

14 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
15 **OF DENVER:**

16 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the
17 United States of America Department of Housing and Urban Development, for the “Housing
18 Opportunities for People with AIDS FY21” program, which is identified as Grant Number COH21-
19 F001, a copy of which is duly filed with the City Clerk, Filing No. 202159910, be and hereby is
20 approved in all respects.

21 **Section 2.** The payments made by the United States of America to the City pursuant to and
22 under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special
23 Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal
24 Code of the City and County of Denver.

25 **Section 3.** That it be and is hereby found and determined that the budget summary of said
26 program, to be expended by the Executive Director of the Department of Housing Stability, is as
27 follows:

29 The foregoing authorization will fund the City’s housing, business, and neighborhood development
30 activities to prevent homelessness including appropriate supportive services and resource
31 identification for persons confirmed with AIDS and HIV. Expenditures of said funds are authorized

1 from July 26, 2021 to July 25, 2024 and apply to the January 1, 2021 to December 31, 2021
2 program year.

4 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized
5 and directed to make such book and record entries and to do such other things as may be necessary
6 to accomplish the purposes of this Resolution.
