BR12-0202 Approves the purchase of a modular LED display from Daktronics, Inc., for Red Rocks Amphitheatre events and for athletic events at the Denver Coliseum.

C. Boards and Commissions - Anthony Aragon

RR12-0197 Approves the Mayoral appointment of Eric Nesbitt to the Denver Housing Authority Board of Directors for a term effective immediately and expiring on July 20, 2013 or until a successor is duly appointed.

BR12-0180 Authorizes a no cost amendment to the Denver Rescue Mission contract with the Denver Department of Human Services, reducing respite care bed days for homeless individuals who require shelter and medical services by 485 bed days, and aligning with a reduction of respite care utilization and a reduction of available funding for services provided in the final year of the contract. The overall contract cost remains at \$613,200 (CE04013).
