12 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

13 **Section 1.** That there is hereby levied for the year 2014 upon all taxable property within
14 School District No. 1 in the City and County of Denver and the State of Colorado, the taxes in mills
15 per dollar of assessed valuation, set forth in the following tabulation, the proceeds of the several
16 levies to be paid into the respective funds named:
