5 **A BILL**

6 **For an ordinance authorizing a capital equipment purchase in the Culture and**  
7 **Recreation Special Revenue Fund.**

9 **WHEREAS**, Ordinance No. 1284, Series of 2021, the Annual Appropriation Ordinance,  
10 authorized the 2022 spending allocation in the Denver Arts and Venues Special Revenue Fund;  
11 and

12 **WHEREAS**, said allocation includes an appropriation to support the purchase of two video  
13 display boards; and

14 **WHEREAS**, the video display boards are capital equipment items that require City Council  
15 approval, per the Denver Revised Municipal Code; however, they were inadvertently excluded  
16 from the capital equipment authorization section of the 2022 Annual Appropriation Ordinance; and

17 **WHEREAS**, this bill request authorizes the purchase of said display boards as a corrective  
18 action;

20 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
21 **OF DENVER:**

23 **Section 1.** From the Denver Arts and Venues Special Revenue Fund, Accounting No. 15815,  
24 the Executive Director of Denver Arts and Venues, or duly authorized representatives, is hereby  
25 authorized to purchase or acquire the following capital equipment:
