### Mission

To serve the people of the City and County of Denver by working to ensure that participation in elections, marriages, recording of real estate, death certificates and public notices and finding documents, and navigating the foreclosure process is easily and equitably accessible, reliable, and secure for all.



### **Denver Voters**

- More than 560,000 registered voters; 458,000+ active
- Voter turnout is typically ~30% in local elections. We expect 85-90% turnout for the Presidential Election.
- We processed 30,000+ voter registration updates monthly in 2024
- 95%+ of our voters use drop boxes and mail; less than 5% vote in person



### **Election Plan**

- 45 secure ballot drop boxes open when ballots go out
- 39 Voter Service and Polling Centers open in phases
- McNichols Central VSPC expansion
- 1,200+ paid election judges; everything bipartisan teams





The Denver Elections Division conducts a Public Logic & Accuracy Test to ensure our equipment is functioning properly

Ballots are mailed out 22 days before Election Day Drop boxes checked daily by bipartisan teams. Ballots are returned to Denver Elections Division for processing












Ballot envelopes are dateand-time stamped at this point



Ballots are scanned and imprinted with a number later used in auditing

Bipartisan teams verify signature discrepancies

#### **Ballots are counted and reported**

First unofficial results are posted at 7 p.m. on Election Day

Official results are not posted until ALL BALLOTS ARE COUNTED and then sent to the Secretary of State for public posting. In the weeks following, a risk-limiting audit is performed to ensure accuracy, and a bipartisan canvass board then certify the results





### **Ballot Information Book**

- We are required by State law to publish and mail all TABOR measures with public comments to all registered voters
- This year, Denver measures will not be printed and mailed but appear online
- Voters can request hard copies by mail, or pick one up at our office or libraries
- Saves taxpayer funds on printing and mailing, and reduces environmental impact

## **Ballot Processing**

- 9 MILLION+ ballot touch points in 15 days
- About 40% of ballots come in on Election Day; 75% of those after polls close
- With a 3-card ballot, that means
   <u>~480,000 cards to count after polls close</u>
- Expect results throughout the night and 8 days post election – we prioritize ACCURACY over speed.

## **Elections Security**

- Threats to elections officials are real, and we take them seriously. <u>We are prepared.</u>
- We work with Homeland Security, Department of Justice, Federal Bureau of Investigation, Secretary of State, Denver Department of Safety and Office of Emergency Operations
- Bipartisan teams in everything we do
- Thorough, regular testing and training
- Multi-agency tabletop exercises
- 2024 Budget allowed us to make necessary and important physical improvements
