Section 1. That the action of the Manager of Public Works in vacating the following described alley in the City and County of Denver and State of Colorado, to wit:

The alley in Block 9, Rosedale, except the north 26 feet thereof be and the same is hereby approved and the described portion of that certain alley is hereby vacated and declared vacated; PROVIDED, HOWEVER, said vacation shall be subject to the following conditions and reservations:

That easements be and are hereby retained to protect the utilities in portion of the alley vacated which utilities include power lines, telephone lines, cable television lines and drainage facilities for water and sewage of the City and County of Denver.
