

## AMENDATORY AGREEMENT

This AMENDATORY AGREEMENT is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”) and **KONE INC**, a Delaware corporation whose address is One Kone Court, Moline, Illinois 61265 (the “Contractor”), jointly (“the Parties”).

### WITNESSETH

**A.** The Parties entered into an Agreement dated **October 29, 2019** (the “Agreement”) perform and complete all modernization and installation of elevators in the Police Administration Building.

**B.** The Parties wish to amend the Agreement to extend the term.

**NOW THEREFORE**, in consideration of the premises and the Parties’ mutual covenants and obligations, the Parties agree as follows:

1. Section 4.0 of the Agreement entitled **TERM OF AGREEMENT** is hereby deleted in its entirety and replaced with:

“4. The Agreement will commence on October 29, 2019 and will expire **May 31, 2022** (the “Term”). Subject to the Manager’s prior written authorization, the Contractor shall complete any Assigned Work in progress as of the expiration date and the Term of the Agreement will extend until the work is completed or earlier terminated by the Manager. The parties agree that in the performance of the terms, conditions, and requirements of this Agreement by the Contractor, time is of the essence.”

2. As herein amended, the Agreement is affirmed and ratified in each and every particular.

3. This Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
