Request for a Resolution for laying out, opening and establishing certain real properties as part of the system of thoroughfares of the municipality as Northfield Blvd., Spruce Way, 49th Pl., and Trenton St from approximately Northfield Quebec St. to Central Park Blvd.

SUMMARY:

The purpose of this resolution is to dedicate Northfield Blvd., Spruce Way, 49th Pl. and Trenton St. from approximately Northfield Quebec St. to Central Park Blvd. as right-of-way.

It is requested that the above subject item be placed on the Mayor-Council Agenda for the next available date.

These parcels of land were deeded to the City and County of Denver by a Special Warranty Deed recorded in the Office of the Denver County Clerk and Recorder on December 24, 2009, under Reception Number 2009166101 to facilitate the Stapleton Filing No. 14 development, which is located between approximately Northfield Quebec St. and Central Park Blvd.

Therefore, you are requested to initiate Council action to dedicate the following as:

(1) Northfield Blvd., median platted inside Tract E as trunk roadway median (shown on the Subdivision Plat as Future R.O.W. for 49th Ave. now herein renamed) between Uinta St. and Verbena St., the land in the following described area:

Tract D, Stapleton Filing No. 14, City and County of Denver, State of Colorado;

(2) Northfield Blvd., from Spruce Way east to Central Park Blvd. (shown on the Subdivision Plat as Future R.O.W. for 49th Ave. now herein renamed), the land in the following described area:

Tract E, Stapleton Filing No. 14, City and County of Denver, State of Colorado;

(3) Spruce Way, from Northfield Blvd. north to 49th Pl., the land in the following described area:

Tract F, Stapleton Filing No. 14, City and County of Denver, State of Colorado;

(8) Northfield Blvd., from the east boundary of Stapleton Filing No. 14 (also the west boundary of Stapleton Filing No. 13) and at approximately Beeler St. west to the east line of Tract E, Northfield Blvd., the land in the following described area:


