5. **General description or background of proposed request. Attach executive summary if more space needed:** This amendment extends an agreement with City employee David Binkley to perform residential caretaker duties and reside seasonally at City-owned property at Echo Lake Lodge, 13264 Chicago Creek Road, Idaho Springs, Colorado 80452. The presence of a live-in caretaker benefits the city due to the remote nature of the building and difficulty of regular access for staff. A live-in caretaker is necessary due to lack of near-by staff to perform regular maintenance and inspections, complexity of mechanical systems (including a well, septic system, and cistern-based fire suppression system), presence of on-site food vendor, and high visitation. As part of Mr. Binkley's caretaker duties, he will reside in and perform official duties to include, among other things, snow/litter/trash removal, securing and inspecting the buildings and grounds, testing the well, providing after-hours security, monitoring the septic system, facilitating contractor and programmatic access to the building, ensuring the fire suppression cistern is full at all times, securing dumpsters from bears, monitoring for pests, responding to extreme weather events, and performing general visitor services. The caretaker will perform these duties outside of regularly scheduled hours in lieu of monetary rent payment consistent with Executive Order No. 27 and other existing caretaker agreements. This agreement is strictly for the benefit of the city to ensure the proper care of Echo Lake Lodge.
