6. **General description of proposed ordinance including contract scope of work if applicable:**

The Court is requesting an ordinance that would extend a contract with the Frank Moya Law Firm(law firm) to provide indigent defense to those that are charged with a municipal ordinance violation but who cannot afford an attorney. The US and Colorado Constitution requires the appointment of an attorney at the court's expense if the individual charged with a crime that is punishable by incarceration does not have the financial means to pay for one. This is the first amendment to the contract that started in 2012 and the cumulative total for both 2012 and 2013 puts it above the \$500,000 threshold for council approval. Only the term and the amount of the 2013 contract have changed.
