## **EXECUTIVE SUMMARY**

The purpose of the resolution to set a public hearing on the service plans for the formation and establishment of two (2) Title 32 metropolitan districts located at the northwest corner of East 51<sup>st</sup> Street and Washington Street: **Globeville Commerce Center Metropolitan District #1 and Globeville Commerce Center Metropolitan District #2**.

The Districts will provide for the construction, financing, operation and maintenance of certain public improvements which are necessary for the successful implementation the development.

State law requires a public hearing be conducted prior to City Council approving a service plan with published notice to commence 20 days prior to the hearing.
