6 **For an ordinance changing the zoning classification for 3200 - 3262 Blake Street.**

8 **WHEREAS**, the City Council has determined, based on evidence and testimony presented
9 at the public hearing, that the map amendment set forth below conforms with applicable City laws,
10 is in accordance with the Comprehensive Plan, is necessary to promote the public health, safety
11 and general welfare of the City, is justified by one of the circumstances set forth in Section
12 12.4.10.14 of the Denver Zoning Code, and is consistent with the neighborhood context and the
13 stated purpose and intent of the proposed zone district;

14 **NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
15 **DENVER:**

16 **Section 1.** That upon consideration of a change in the zoning classification of the land area
17 hereinafter described, Council finds:

- 18 1. That the land area hereinafter described is presently classified as R-MU-30, with waivers.
19 2. That the Owner proposes that the land area hereinafter described be changed to C-MX-5.

20 **Section 2.** That the zoning classification of the land area in the City and County of
21 Denver described as follows or included within the following boundaries shall be and hereby is
22 changed from R-MU-30, with waivers, to C-MX-5.

24 **Lots 1 to 16 Inclusive, Block 20, Case & Ebert's Addition to the City of Denver.**
