Business, Workforce & Sustainability

- RR13- Approves the Mayoral reappointment of Rita Kahn to the Stapleton
0405 Development Corporation Board of Directors for a term effective July 1,
2013 and expiring on June 30, 2018.

Government & Finance

- BR13- Amends the maximum dollar amount for petty theft from \$1,000 to
0408 \$2,000 reflecting a new state law on misdemeanor theft.

Health, Safety, Education & Services

- BR13- Appropriates 50% of the United States Department of Health and
0410 Human Services grant by a Letter of Intent for the Head Start program
year 2017 beginning July 1, 2013 through June 30, 2014 in the amount
of \$8,365,346 to provide education, health, dental, mental health,
nutrition, and family services for 3- to 5-year old children and their
families.
- BR13- Approves a contract with Smiths Detection for the purchase of three
0412 body scanners in the amount of \$540,939 to be used at the Downtown
Detention Center and the County Jail facilities for the safety of the
inmates, officers, and public.
- BR13- Approves an amendment to the Century Helicopters, Inc. contract to
0413 extend the term of the agreement through June 30, 2015, and to add
\$377,400.15 for the continued maintenance of the Denver Police
Department helicopter (CE61220-04).
- BR13- Amends the contract with Alcohol Monitoring Systems, Inc. to extend
0414 the agreement through December 31, 2013 and to add \$350,000 for
continuing electronic monitoring services and equipment to monitor
offenders under supervision of the Electronic Monitoring Program

(CE41246-06).

- RR13- Approves the Mayoral re-appointments of Dolores Atencio, Lance
0404 Benninghoff, Michele Ostrander, and Mackenzie Roebuck-Walsh, and the
appointments of Jessica Acosta, Lilly Berger, Miriam Pena, Corelle
Spettigue, Lynne Valencia, and Kara Veitch to the Denver Women's
Commission for terms effective immediately and expiring on June 30,
2015, or until a successor is duly appointed.
- BR13- Amends the 2011 Denver Building and Fire Codes to allow for the
0392 transfer of the Conveyance Inspection Program from the State of
Colorado to the City and County of Denver Fire Department.

Land Use, Transportation & Infrastructure

- BR13- Revokes Ordinance 858, Series 2004, granting a revocable permit to
0415 Streamline Restoration to encroach into the public right-of-ways of 8th
Ave. and Kalamath with two steel canopies which are now included in an
updated permit granted by Ordinance 41, Series 2013, in Council
District 9.

Routine, non-controversial requests for ordinances that are not substantive policy changes may be placed on Consent Agendas for Council Committees each week with the approval of Committee chairs. Councilmembers receive the consent agendas for review and have until Thursday at noon to request that an item be scheduled for Committee discussion.
