6 **A BILL**

8 **For an ordinance establishing a new fund in the General Government Special**  
9 **Revenue Fund for the “Special Districts Revolving Loan Fund”.**

10  
11 **WHEREAS**, the Department of Finance requests a new fund for the “Special Districts  
12 Revolving Loan Fund” to support the continued creation of Business Improvement Districts (BID)  
13 and General Improvement Districts (GID) in the City and County of Denver; and

14 **WHEREAS**, BIDs and GIDs promote businesses in targeted districts through specific  
15 marketing, place making activities and enhanced level of services; and

16 **WHEREAS**, the 2018 Annual Appropriating Ordinance includes a General Fund transfer in  
17 the amount of \$200,000 in seed money for a “Special Districts Revolving Loan Fund”;

18 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
19 **DENVER:**

20 **Section 1.** A new fund is hereby established in the General Government Special Revenue  
21 Fund, Accounting No. 11000, a “Special Districts Revolving Loan Fund”, Accounting No. 11865 for  
22 the purpose of accounting for the receipt and expenditure of program dollars.

23 **Section 2.** Monies received from an initial one-time \$200,000 transfer from the General Fund  
24 in 2018, payments, interest, and other sources of revenue including transfers from other City  
25 funds, shall be deposited into the Treasury of the City and credited to Special Fund No. 11000,  
26 which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and  
27 County of Denver.

28 **Section 3.** Program expenditures are hereby authorized for the “Special Districts Revolving  
29 Loan Fund”, Accounting No. 11865, in the amount not to exceed the total of deposits described in  
30 Section 2 of this ordinance to be expended by the Chief Financial Officer. Authorized expenditures  
31 include advancing the cost of acquisition, installation, maintenance, and financing of  
32 enhancements in the public right of way. These enhancements can include but are not limited to  
33 specialized cross walks, improved sidewalks, additional pedestrian lighting, wayfinding signs,  
34 planters, and bus shelters. The initial funding is appropriated with subsequent appropriation  
35 established on a cash basis as the program matures. This is a cash basis, non-lapsing fund.
