A RESOLUTION

Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the Caring for Denver Foundation concerning the “DPD Co-Responder” program and the funding therefor.

9 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
10 Grant Agreement;

12 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**

15 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the
16 Caring for Denver Foundation for the “DPD Co-Responder” program, which is identified as Grant
17 Number 202505-03920, a copy of which is duly filed with the City Clerk, Filing No. 202581722, be
18 and hereby is approved in all respects.

19 **Section 2.** The payments made by the Caring for Denver Foundation to the City pursuant to
20 and under the Grant Agreement shall be deposited into the Treasury of the City and credited to
21 Special Revenue Fund No. 12000, which is set forth and described in Section 20-18 of the Revised
22 Municipal Code of the City and County of Denver.

23 **Section 3.** That it be and is hereby found and determined that the budget summary of said
24 program, to be expended by the Executive Director of Safety, is as follows:


27 Expenditures of said funds are authorized from September 1, 2025 to August 31, 2026.




