FIRST AMENDMENT AND MODIFICATION AGREEMENT

THIS FIRST AMENDMENT AND MODIFICATION AGREEMENT (this "First Amendment") is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and DENVER RESCUE MISSION, a Colorado nonprofit corporation, whose address is 3501 E. 46th Avenue, Denver, Colorado 80216 (the "Borrower").

WITNESSETH:

WHEREAS, the City and Borrower entered into that certain Loan Agreement dated September 20, 2005 (the Loan Agreement"), relating to a loan of Seven Hundred Fifty Thousand (\$750,000); and

WHEREAS, Borrower is bound by the covenants and obligations under that certain Deed of Trust (the "Deed of Trust") dated December 12, 2005 recorded on December 13, 2005 at Reception No. 2005211634 for the benefit of the City, and encumbering the real property more specifically described in **Exhibit A** attached hereto and incorporated herein by this reference (the "Property"); and

WHEREAS, the Deed of Trust secures the repayment of the indebtedness evidenced by that certain Promissory Note executed by Borrower and for the benefit of the City, dated December 12, 2005 (the "Note"); and

WHEREAS, Borrower encumbered the Property with certain rental and occupancy limitations pursuant to that certain Rental and Occupancy Covenant (the "Covenant") dated December 12, 2005 recorded in the records of the Clerk and Recorder of the City and County of Denver on December 13, 2005 at Reception Number 2005211635; and

WHEREAS, the parties wish to modify the terms and conditions of the Loan Agreement, Note, Deed of Trust, Covenant, and any other documents evidencing or securing the City's loan

(together, the "Loan Documents"), to modify the amount of prior encumbrances found in Paragraph 3 of the Loan Agreement; and

NOW, THEREFORE, in consideration of the mutual agreements herein contained, the parties agree as follows:

- 1. Paragraph 3 of the Loan Agreement entitled "SUBORDINATION," is hereby amended to read as follows: The Director of the City's Office of Economic Development ("OED") or permitted designee, is authorized to execute documents necessary to subordinate the lien of the City's Deed of Trust so long as (i) such documents are in a form satisfactory to the City Attorney; (ii) encumbrances prior to the City's Deed of Trust do not exceed \$7,000,000.00; and (iii) Borrower is not then in default of its obligations pursuant to this Loan Agreement, the Promissory Note, or the Deed of Trust.
- 2. The Parties consent to the use of electronic signatures by the City. The Agreement, and any other documents requiring a signature hereunder, may be signed electronically by the City in the manner specified by the City. The Parties agree not to deny the legal effect or enforceability of the Agreement solely because it is in electronic form or because an electronic record was used in its formation. The Parties agree not to object to the admissibility of the Agreement in the form of an electronic record, or a paper copy of an electronic document, or a paper copy of a document bearing an electronic signature, on the ground that it is an electronic record or electronic signature or that it is not in its original form or is not an original.
- 3. Except as modified herein, the Loan Documents remain in force and are hereby ratified and reaffirmed.
