**A BILL**

**For an ordinance making a rescission from and an appropriation in the Wastewater Management Operations Fund to make a cash transfer to the Wastewater Management Division Planned Fleet Replacement Fund.**

**WHEREAS**, the Wastewater Management Division Planned Fleet Replacement Fund, Fund 72200, was established through Ordinance No. 1294, Series of 2019, after the 2020 Budget was finalized, to create a non-lapsing Fund to purchase vehicles for the Wastewater Enterprise Fund; and

**WHEREAS**, the 2020 Budget includes appropriations in the Wastewater Management Operations Fund for the purchase of vehicles that would have been budgeted in the Wastewater Management Division Planned Fleet Replacement Fund, had it been established prior to finalizing the 2020 Budget; and

**WHEREAS**, the cash transferred through this Ordinance corresponds to budget appropriated in the Wastewater Management Operations Fund for vehicles authorized in the 2020 Budget; and

**WHEREAS**, a cash transfer to the non-lapsing Fund is desired because the authorized vehicles may not be purchased before year-end;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the Wastewater Management Enterprise Fund there is hereby RESCINDED the amount listed or indicated in the following tabulation under the heading "Amount Rescinded" and transferred to the Wastewater Management Enterprise Fund:

 2 monies rescinded from Section 1 not otherwise appropriated and in addition to amounts heretofore  
 3 appropriated by Ordinance No. 1193, Series of 2019, and any supplemental appropriations or  
 4 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the  
 5 amount of money following such designation, to be expended for the purposes and upon the  
 6 authorizations in said Ordinance set forth:
