

The North Denver Cornerstone Collaborative (NDCC), an initiative of Mayor Hancock, is a coordinated effort among city departments and community partners to ensure integrated planning and deliberate connections among the converging projects taking place in Denver's Globeville, Elyria, Swansea (GES), and River North (RiNo) communities.
