8 For an ordinance amending the salary of the District Attorney

10 WHEREAS, § 20-1-301 (1)(b), C.R.S., provides that any salary amount for the district
11 attorney in excess of a statutory minimum amount shall be set by the city council of the City
12 and County of Denver for the second judicial district; and

14 WHEREAS, according to § 20-1-301 (1)(a)(V), C.R.S., the current mandatory minimum salary
15 for district attorneys in Colorado is \$130,000, of which amount the state pays 80% as required by §
16 20-1-306, C.R.S.; and

18 WHEREAS, the city council has conducted the quadrennial review of the salary of the district
19 attorney as required by section 18-95 (b)(4), D.R.M.C. and has determined to adjust the annual salary
20 of the district attorney as set forth herein.

22 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
23 **DENVER:**

25 **Section 1.** Paragraphs (1), (2) and (3) of subsection (b) of section Subsection 18-95, Denver
26 Revised Municipal Code, is hereby amended by deleting the words stricken and adding the words
27 underlined to read as follows:

29 **Sec. 18-95. District attorney.**

31 (b) *Salary of District Attorney.*

1 (1) ~~For 2013 and 2014, the district attorney of the second judicial district~~
2 ~~shall continue to be paid an annual rate of \$207,000.~~

4 (2) ~~Effective January 1, 2015, the district attorney of the second judicial~~
5 ~~district shall be paid an annual rate of \$213,210.~~

6
7 (3) ~~Effective January 1, 2016, the district attorney of the second judicial~~
8 ~~district shall be paid an annual rate of \$219,606.~~

9
10
11 (1) For 2017 and 2018, the district attorney of the second judicial district
12 shall continue to be paid an annual rate of two hundred nineteen
13 thousand six hundred six dollars (\$219,606.00).

14
15 (2) Effective January 1, 2019, the district attorney of the second judicial
16 district shall be paid an annual rate of two hundred twenty-three
17 thousand nine hundred ninety-eight dollars (\$223,998.00).

18
19 (3) Effective January 1, 2020, the district attorney of the second judicial
20 district shall be paid an annual rate two hundred twenty-eight
21 thousand four hundred seventy-eight dollars (\$228,478.00).
