It is requested that the above subject item be placed on the Mayor-Council Agenda for the next available date.

Each of these parcels of land were deeded to the City and County of Denver by a Special Warranty Deed recorded in the Office of the City and County of Denver, Clerk and Recorder: Tract A of Stapleton Filing No. 5 on January 16, 2007, under Reception Number 2007006463 and Tract J of Stapleton Filing No. 9 on July 22, 2015 under Reception Number 2015101444, Both to facilitate the Stapleton Filing No. 5 and 9 developments, which are located between 29th Ave. and Martin Luther King, Jr. Blvd. and between Quebec St. and Beeler St.

Therefore, you are requested to initiate Council action to dedicate the following as:

(1) Uinta St., from 29th Ave. north to Uinta St. of Stapleton Filing No. 9, the land in the following described area:

Tract A, Stapleton Filing No. 5, City and County of Denver, State of Colorado;

(2) Uinta St., from Uinta St. of Stapleton Filing No. 5 north to Martin Luther King, Jr. Blvd., the land in the following described area:

Tract J, Stapleton Filing No. 9, City and County of Denver, State of Colorado;
