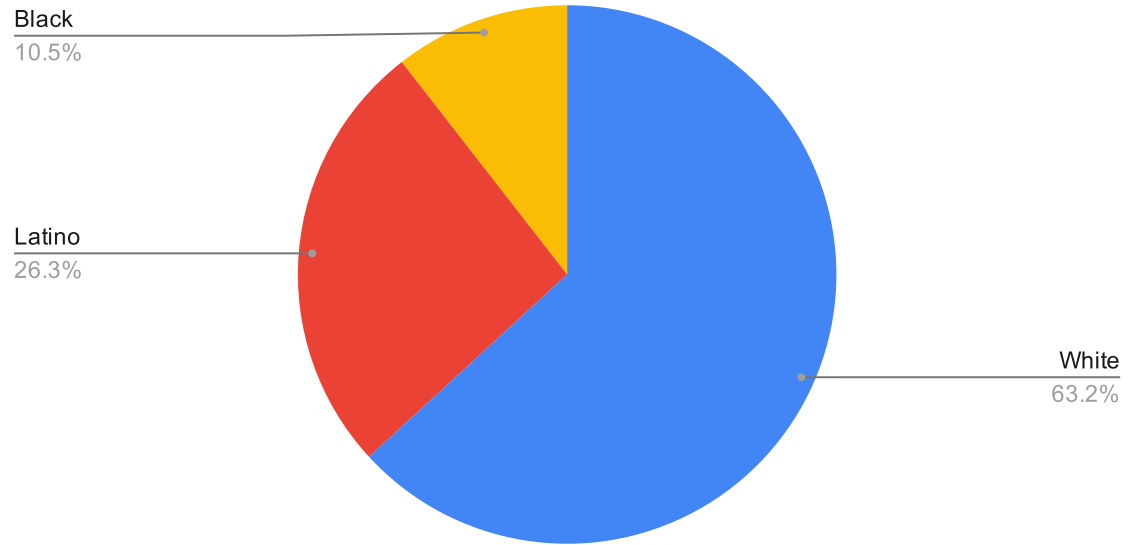

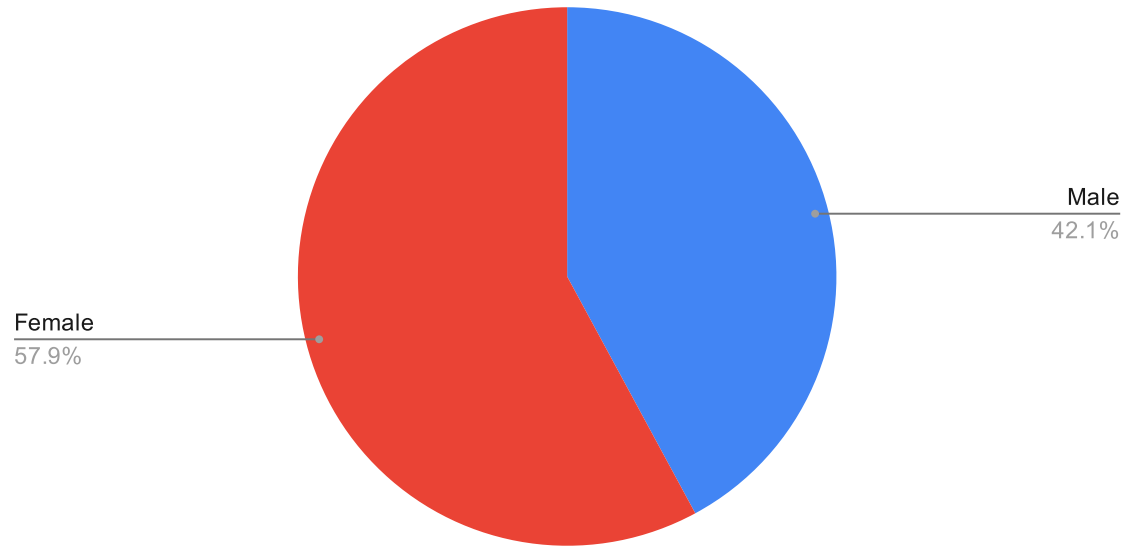
Racial breakdown

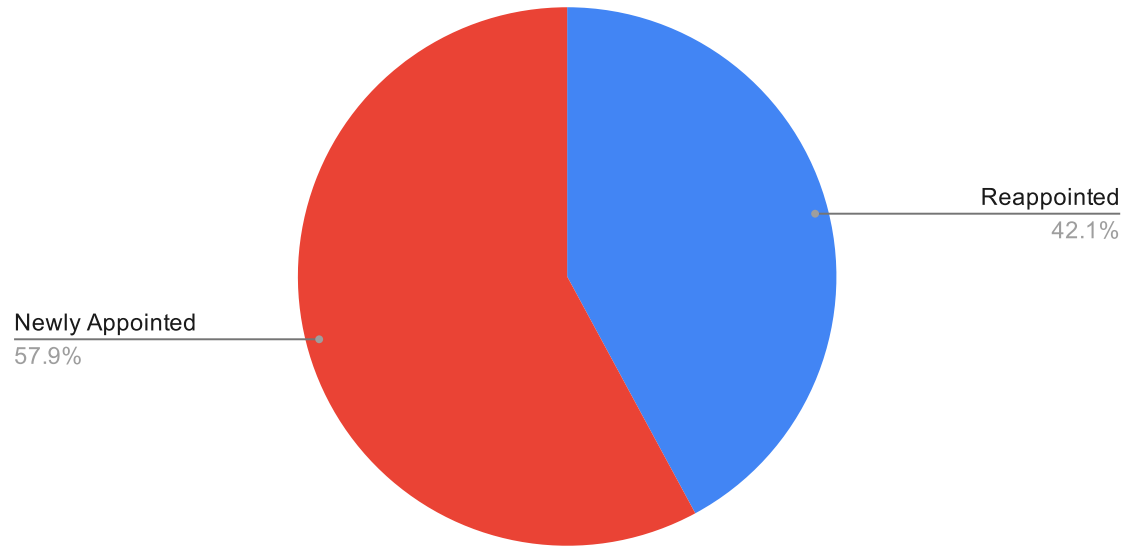
Gender breakdown
