Since its inception in 2001, Colorado Dragon Boat (CDB) has celebrated and promoted the culture, contributions and accomplishments of Colorado's Asian American, Native Hawaiian, Pacific Islander (AANHPI) communities through its preeminent event, the Colorado Dragon Boat Festival, the largest dragon boat festival in the United States and largest AANHPI event in the Rocky Mountain Region, as well as other year-round activities. The festival is a two-day summer event at Sloan's Lake Park, held in accordance with a duly issued DPR Public Event Permit, that features athletic dragon boat races, multicultural entertainment and immersive educational activities, diverse culinary experiences, and a vibrant marketplace showcasing small and minority and women-owned local businesses and information booths featuring numerous Colorado public and private organizations.

In support and furtherance of CDB's mission and this one-of-a-kind community event, DPR seeks to grant a license to CDB to store and moor their boats on Sloan's Lake during the practice season, April - October. In return for this license, CDB will provide additional programming and events beyond the festival that benefit the residents of Denver and Sloan's Lake Park visitors, including free open paddle nights, community service clean-up days, AANHPI Emerging Leaders Program and Colorado Dragon Boat Teambuilding.
