Ms. Torres,

We received a notification of a request for rezoning at 700 N Mariposa street. We are aware of the intention of Haven of Hope to start a residential program there and we are vehemently opposed to this idea. Haven of Hope is currently a 'day shelter,' meaning they are there from 07:00 until 13:00, after which the clients they serve remain in the neighborhood (campers) and create various disturbances such as arguments, wandering around and cursing, brawls, not to mention the heaps and piles of garbage which build up on the sidewalks and streets. There is also considerable drug usage and casual vandalism of gardens, etc. I do not feel like a residential shelter will benefit this neighborhood. It is zoned for residential and industrial. We and our neighbors do not welcome the random violence, the profane exchanges individuals have with each other or with empty air, the uneasy feeling of wondering if our cars have been molested overnight, not to mention the moments of personal threat, that having a day shelter in the neighborhood brings, I can only imagine that a residential shelter will exacerbate these issues even further.

Moving out of the neighborhood is a very difficult option, given the current market and tax rates. We could of course move out of state, but that would not be our desired choice. Please don't make our neighborhood any worse than it already is. We would far prefer to make it better. A residential shelter will not do that.

As the proposal was explained to us last year, it would be a 10 bed facility with a school of sorts. I am all for educating people out of their difficulties, and I am not without compassion, but the presence of Haven of Hope brings in many campers. These unsanctioned camps bring in many problems, including mentally disturbed and/or addicted individuals ranging from the character we call 'the town crier' who sits on the corner and announces his scatological grievances to the world to the woman who wanders the streets in the small hours cursing and swearing. There are an abundance of individuals who threaten each other and anyone who comes close, including the ones that swing sticks and such at each other and passers-by.

Believe it or not, this area is also residential. I live here. My neighbors the Avilas live here, as do the folks renting down on the northern end of the block. There are homeowners on the east side of the street. We already have enough problems which Haven of Hope attracts to the area. I believe that having a residential facility there will only increase our security issues. I have not seen a plan that would address these security issues. Nor do I believe Denver Police should be burdened with the increased level of security we would need.

We operate a business here and pay inordinate taxes to the city. I would like to live in a clean environment, without trash left on my street by campers, and without the constant need for high alertness when I walk out the door. Do you scan out the window for threats before you venture out? I do.

I do not feel that a residential facility will improve my neighborhood.

Hello to all of my neighbors around the 700 block of Mariposa St. I am writing to state my feelings and opinions about and concerns regarding the change of zoning being requested by Haven of Hope for 700 Mariposa St. I own Big K Construction located at 729 Mariposa St., basically across the street from where you are seeking to make changes now.

As I have expressed on many occasions to anyone who was interested, as well as to the staff that operates Haven of Hope, I can appreciate what your facility does to assist the homeless population of Denver, but I do not appreciate the side affects of what your facility does. And I have yet to see any attempts to try and minimize any of the many impacts that HoH has upon the neighboring community.

I have lost count with how many times that I have had to shovel human feces out of my alley somewhere near my driveway's gate. Most recent was probably 5 weeks ago. And while most would probably say why do I care about what happens in the alley? I care because I come and go from my woodworking shop via the alley entrance, and I truly do not appreciate the stench of human waste baking in the sun when I hop out of my truck to open or lock the driveway gate. I feel the near similar level of revulsion when I drive across 7th Avenue in front of your facility and see someone pissing from their car door or right next to their car while they are parked there to camp overnight or even in broad daylight while HOH is open. I have asked on several occasions that Haven of Hope provide portolets for their clients who camp there on 7th Avenue across from the facility, but like every other request for assistance, all I get is that I am told "We will talk with the guys, they know that they shouldn't be doing that", and nothing ever changes.

So now I hear that Haven of Hope is asking for a zoning change for a new address that they have acquired, 700 Mariposa St. And my understanding is that you are proposing a one story addition on top of the existing structure that is there now. And this addition is to provide 10 bed facility of some sort to work in conjunction with your ongoing homeless assistance operation. Personally I am very skeptical of your request. If/once you have obtained this zoning change that you are seeking, what is to stop you from instead of building only one additional story onto that address, to have a sudden change of heart and building another 5 story structure with many more than just 10 beds available for homeless guests? And this is what I believe are your true intentions for that property.

I actually have several questions and concerns with regards to any expansion of services at this location. Will Haven of Hope have anyone here on site 24/7 to supervise and take care of any needs or issues that pop up after hours? Or are you again planning on everyone on staff will go home after their regular work day and the neighborhood and/or Denver Police Dept. will be expected to take care of any issues and concerns that arise after hours/overnight?

And what are your plans to accommodate parking needs for this facility? Because I have yet to hear even a whisper with regards to satisfying your off street parking needs for this new property. As a matter of fact the adjacent property for Haven of Hope, located at 1101 W 7th Ave, has gone thru 2 major expansion projects already, and you have yet to provide even one space of off street parking for your guests and staff. Instead the curbs along 7th Ave as well as along Lipan and Mariposa Street have borne the brunt of your parking needs, and those needs are truly significant. And that arrangement has left little to no available parking for nearby businesses and residents during the day. The situation has become so tight full sized buses and a large RV camper that come to provide mobile health care or mobile veterinary care for your clients have to park in the street to provide this care. It is not right that your facility is relying on the taxpayers to bear the brunt of your parking needs. These kinds of abuses and accommodations would never be accepted or tolerated for any other business use under any building or zoning code. And now you would like to seek a zoning change and increase you footprint and subsequent impact upon this neighborhood?

Dear Mr. Lechuga,

Thank you for hearing us all out and getting these emails included with the application materials.

My partner and I bought the building at 621 Kalamath St over 13 years ago. We immediately refurbished the entire building and filled it with tenants. The first year we were open we won a CBCA award for "best workspace in Colorado". I don't think any of this would have been possible without being such a great neighborhood and just a key location in the city of Denver. We feel very proud to be sitting at one of the main intersections where people enter the city of Denver.

Our main concerns are for the safety of our tenants, guests and our neighbors. I really feel for the people raising families and dealing with some of the increasing concerns we are seeing.

We also rent the lots under the Route 6th viaduct on the east and west side of Lipan.

The amount of time, money and resources we have put into not only keeping our property clean, safe, lit and protected is enormous. Especially when you include the area under route 6 which is a never ending dumping ground and encampment area. I have to give Shaw Construction some props for having their construction crews and security help out during their construction of the new multi unit residential project on Lipan.

To give some examples that back up the stories other concerned neighbors have shared in this email thread -

- A couple months ago we were broken into. 3 nights later the criminals came back again. This time backing a flatbed truck through our door. My partner got the alarm notice. Our security company notified police. He called 911. Frank watched our building with a truck crashed through the door being robbed as he talked live with dispatch. Frank's timeline has him on the phone with dispatch at 12:17am and the criminal final spooking by the alarm at 12:32. 15 solid minutes for the police to have shown up and apprehended this person red handed. They showed up after he left. Then did not even wait the 15 more minutes for Frank to show up. Instead he arrived to find our building wide open with no one on site.

- Last summer I had an experience that still haunts me. I arrived at Battery621 early in the morning. Saw our dumpster was unlocked as it often is after being emptied. I locked it and started to walk away. This was a summer morning and the sun was not yet on the dumpster. In another hour it would be and this was a day then went over 100-degrees in Denver. As I walked away, I thought I heard something. I walked back and looked behind the dumpster as individuals often set up

there. No one behind it. I heard something again and my heart went into panic mode. I unlocked the lid, lifted it and was looking eye to eye with a woman sitting in the dumpster. I immediately called 911 as I helped her out. She was muttering suicidal thoughts. I pleaded for Denver PD to send help. I could not get her to stay so I walked with her to 7-11 and got her some food and water. All the while, hoping I would get a call back from dispatch. Nothing.

This woman almost perished that day. I was probably about three steps away from that becoming reality.

- All of our propane tanks were stolen from our locked lot. This was well over \$1000 dollars of our property. Most likely to fuel the unregistered RV's parked all over our neighborhood. Maybe to assist in the making of meth. Who knows.
- We are cleaning human waste and needles and other threats to health and safety on a daily basis. We often arrive at our office to find human waste right on our main entry points.
- Endless episodes with individuals threatening people coming and going to our building
- Endless vandalism to vehicles and property
- Open fires under route 6 viaduct. RV's burning to the ground on Lipan.
- It is not only an encampment on Lipan and Mariposa right now but a garbage dump

I could go on and on. The main point is we need to work on improving what is already in place, not expanding and creating new problems that will not be solved. If the people who really care about this neighborhood are forced out, it is over.

Happy to help in any way we can. Thank you for listening and passing this on to the decision makers.

Participants for the program, (Fresh Tracks), come from the population already coming to HOH for basic emergency services. We don't anticipate any increase to the unhoused population in our neighborhood. We are hoping over time to actually reduce the number of individuals experiencing homelessness. We are a small organization and can only handle approximately 8-10 in this program at a time. It is also worth noting that upon completion of the renovation we will have 24/7 security of our property.

I say this with utmost respect for Tawnya and anyone else involved:

If you recognize your own need to bring 24/7 security to a project/property, you are inherently suggesting that YOU are concerned about the safety. I started typing metaphors to express how overt this is, but I think it tells the story well enough.

Dear Mr Lechuga,

Thank you for giving a voice to the neighborhood and my concerns about the zoning of 700 Mariposa as a residential facility for Haven of Hope. I've been an owner of 743 and 747 Kalamath St since December of 2021, bringing our creative production company and its employees to this space to make it our home for the indefinite future.

I have ~20 employees working on the property, half of which are female. While we've invested extensively to make the inside of our office a great/healthy work environment, we've continually run into challenges where our employees don't feel safe in the area outside the building. The unhoused and other non-resident population makes our alley a homebase for dumping trash, rampant drug abuse, damage (we've had two people light piles of clothes on fire outside our garage in the last year), sleeping/passing out, and general disrespect/yelling at our people. As a result, employees try to leave the office early in the winter to avoid being here when it's dark, and even earlier in the summer because of how much busier it gets with good weather.

This brings me to Haven of Hope. We don't cite the organization itself as the primary cause for our current situation, nor are we against their mission. But the change brought by this new Fresh Tracks project is one that brings significant potential risks for an uptick in issues.

1) Currently, the facility only services individuals until 1pm. If the new facility is opened, there is potential for an influx of individuals in all other hours of the day, which could exacerbate our current problem.

2) Haven of Hope already knows about the challenges we face today, and how this could affect everyone. Only upon expressing our concern about the project did I feel like there was any communication with them, and their promise that THEY will have 24/7 security on their own property (per email correspondence with their Executive Director) shows that they're concerned about the fact that they'll need it. We're half a block away. This implies that we too will need 24 hr security.

3) The increase in police protection we'd need to support an influx of people/more encampments just isn't worth their time. We want to prioritize police resources to other places, and this will just lead to even more monitoring they'll need to do in the neighborhood.

I am resubmitting my message that I had sent to Ms. Jamie Torres to express my opposition to Haven of Hope's request to operate as a residential care facility on our block. According to the City's website, Type 1 residential care allows "up to 10 guests year-round, or up to 100 guests for a maximum of 130 days per year," and Type 2 "11 to 40 guests." This would translate to approximately 140 residents facing our front door.

These numbers and the activity they will generate are overwhelming.

Haven of Hope is already a magnet and has directly contributed to an RV-tent encampment around our business and has proven to be a constant challenge to deal with.

We understand the difficulty Denver and the nation are facing with homelessness, however, I believe that it is beyond unfair to expect a few small businesses to suffer from zoning decisions that negatively impact business operations and property valuations.

I am a media producer and have had a number of clients and associates express unease with our office location because of its close proximity to homeless activity.

Allowing Haven of Hope to expand to Type I and Type II residential care will only aggravate the current situation and is punitive to our business.

I strongly urge the Planning Board and City Council to deny Haven of Hope's request.
