4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**  
6 **of land as South Santa Fe Drive near the intersection of South Santa Fe Drive**  
7 **and West Arizona Avenue.**

9 found and determined that the public use, convenience and necessity require the laying out, opening  
10 and establishing as a public street designated as part of the system of thoroughfares of the  
11 municipality that portion of real property hereinafter more particularly described, and, subject to  
12 approval by resolution has laid out, opened and established the same as a public street;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening  
15 and establishing as part of the system of thoroughfares of the municipality the following described  
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,  
17 to wit:

19 1234 SOUTH SANTA FE DRIVE – 12.5 FOOT WIDE PARCEL  
20 A Portion of the Northwest ¼ of Section 22, T. 4 S., R. 68 W. of the 6th P.M.  
21 City and County of Denver, State of Colorado.

23 A parcel of land being the West 12.5 feet of Lots 30 to 33, Block 7, West Broadway Addition, City  
24 and County of Denver, State of Colorado

26 be and the same is hereby approved and said real property is hereby laid out and established and  
27 declared laid out, opened and established as South Santa Fe Drive.

28 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known  
29 as South Santa Fe Drive.
