A BILL

For an ordinance modifying paragraphs (6)d and e of section 121 of Chapter 39 of the Revised Municipal Code, relating to fees and charges for rental of facilities at Botanic Gardens and Chatfield.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That paragraphs d (Facilities fees) of subsection 6 (Botanic Gardens fees) of section 121 (Schedule for Use of Facilities) of Article IV (Fees and Charges) of Chapter 39 (Parks and Recreation) of the Revised Municipal Code shall be amended by deleting the language and numbers stricken and adding the language and numbers underlined, as follows:

Sec. 39-121(6) *Botanic Gardens fees:*

- d. Facilities fees; maximum rate charges for use of Botanic Gardens facilities which may be discounted by Denver Botanic Gardens:
