14 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
15 Grant Agreement;

17 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF**

20 **Section 1.** The proposed Grant Agreement, under CFDA No. 14.267, between the United  
21 States of America Department of Housing and Urban Development and the City and County of  
22 Denver, which is identified as Grant Number CO0104L8T031710, a copy of which is duly filed with  
23 the City Clerk, Filing No. 201842995-00, be and hereby is approved in all respects.

25 **Section 2.** The payments made by the United States of America to the City pursuant to and  
26 under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special  
27 Revenue Fund No. 13000, which is set forth and described in Section 20-18 of the Revised  
28 Municipal Code of the City and County of Denver.
