6 **A RESOLUTION**

8 **A resolution extending the declaration of local disaster filed with the clerk and**  
9 **recorder to January 11, 2021.**  
10

11 **WHEREAS**, the occurrence or imminent threat of widespread or severe damage, injury or  
12 loss of life or property resulting from COVID-19 continues to require emergency action and  
13 resources to avert danger or damage and to protect public health;

14 **WHEREAS**, on March 12, 2020, Mayor Hancock filed with the CCD Clerk and Recorder, a  
15 State of Local Disaster Emergency Declaration (hereinafter "Declaration");

16 **WHEREAS**, the period of Declaration is currently in effect until Monday, August 24, 2020;  
17 and,

18 **WHEREAS**, pursuant to state law, Colo. Rev. Stat. §24-33.5-709(1), the effect of the period  
19 of local disaster cannot exceed seven days except by or with the approval of City Council;

20 **WHEREAS**, out of an abundance of caution, City Council intends to further extend the  
21 current declaration until Monday, January 11, 2021, in accordance with the recommendations from  
22 local, state and federal health officials; and,

23 **WHEREAS**, this emergency declaration is necessary for the City to continue to receive  
24 federal public assistance funds for emergency protective measures; and

25 **WHEREAS**, the emergency declaration gives the City the ability to expedite procurement for  
26 critical services that provide shelter for people in need and purchase protective equipment for  
27 Denver's essential workers, among other time-sensitive needs;

29 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

30 **Section 1.** That the State of Local Disaster Emergency Declaration prepared by Mayor  
31 Michael B. Hancock and filed with the Clerk and Recorder of the City and County of Denver on  
32 March 12, 2020, be extended until January 11, 2021, and shall be in effect until terminated by the  
33 Mayor or by City Council in accordance with state and local laws.
