8 **For an ordinance amending Ordinance 235, Series of 2008 concerning the “Event**  
9 **Facility Fund” and transferring cash within the Culture and Recreation Special**  
10 **Revenue Fund.**

12 **WHEREAS**, the Department of Parks and Recreation requests removing all language  
13 concerning the Chief Hosa Campground from Ordinance 235 Series 2008; and

14 **WHEREAS**, the remaining cash balance for the Chief Hosa Campground currently in the  
15 Event Facility Special Revenue Fund will be transferred to the Denver Mountain Parks Special  
16 Revenue Fund;

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
18 **OF DENVER:**

19 **Section 1.** That Sections 1 and 2 of Ordinance 235, Series 2008, are hereby amended to  
20 read as follows:

21 “Section 1. There is hereby established in the Culture and Recreation Special Revenue  
22 fund, Special Fund No. 15000, an “Event Facility” special revenue fund, Accounting No.  
23 15823-7010000, for the purpose of accounting expenditures related to the operation,  
24 maintenance and capital improvements of the Washington Park Boathouse, Chief Hosa  
25 Lodge, City Park Pavilion, The Molkery (Montclair Civic Building), and the concession building  
26 at Stapleton Central Park.

27 Section 2. Monies generated from activities, charges, rentals, concession license  
28 agreement, or other revenues related to the Washington Park Boathouse, Chief Hosa Lodge,  
29 City Park Pavilion, the Molkery (Montclair Civic Building), and the concession building at  
30 Stapleton Central Park facilities shall be deposited into the Treasury of the City and credited  
31 to Special Fund No. 15000 which is set forth and described in Section 20-18 of the Revised  
32 Municipal Code of the City and County of Denver, and specifically to the “Event Facility”  
33 special revenue fund No. 15823.”

1       **Section 2.** There is hereby authorized the transfer of the final ending cash balance as of  
2 December 31, 2017 from the "Chief Hosa Campground" funds in the Event Facility SRF (15823-  
3 7010000) to the Denver Mountain Parks SRF (15825-7020000) within the Culture and Recreation  
4 Special Revenue Fund.

6       **Section 3.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
7 and directed to make such book and record entries and to do such other things as may be  
8 necessary to accomplish the purposes of this Ordinance.
