6. **General description of proposed ordinance including contract scope of work if applicable:**

The City entered into a Cooperative Agreement with the Denver Inner City Parish on December 07, 2010 allowing them to utilize the City-owned College View Recreation Center at 2525 South Decatur Street to administer and provide youth and community programming at the Recreation Center. This agreement ran through December 31, 2011 and had provisions allowing for four one-year extensions at the discretion of the Manager of Parks and Recreation. Two of these extensions have been approved to date resulting in December 31, 2013 being the current end date of the agreement (with two one-year extensions remaining).

This amendment 1) eliminates the two remaining one-year extensions and changes the termination date to June 30, 2018, 2) allows The Inner City Parish to operate a Day Camp at the Recreation Center during summer school breaks, 3) reduces the amount of utility costs that is paid for by the City, 4) clarifies the financial responsibilities related to repairs and preventative maintenance, and 5) adds a clause allowing for electronic signatures.
