A BILL

For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States of America concerning the "Ryan White Part A FY12" program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, under CFDA No. 93.914 between the United States of America, Department of Health and Human Services, and the City and County of Denver, which is identified as Grant Number H89HA00027-19-00, a copy of which is duly filed with the City Clerk, Filing No. 12-0125, be and hereby is approved in all respects.

Section 2. The payments made by the United States of America to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 14000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Ryan White Part A FY12" Program, Accounting No. 14002-6501101-E1047 is as follows, to be expended by the Manager of Environmental Health:

Authorization for expenditure of said funds following execution of said grant will cover the period from March 1, 2012 to February 28, 2013.
