5. General description or background of proposed request. Attach executive summary if more space needed:

Ordinance will allow the execution of the grant agreement between CCD and the State of Colorado regarding the FY24 UASI funds. The ordinance will also allow MOOEM, as the administrator for this grant, to procure the following capital equipment on behalf of Denver or neighboring UASI agencies with this grant:

- Metro Area Radio Cooperative ISSI Funding (City of Arvada and Lakewood):** Funding for the sustainment and maintenance of the L3-Harris ISSI platform connecting regional P25 LMR systems. This ensures uninterrupted voice communications for first responder agencies in the North Central Region.
- Douglas County Bomb Truck (Douglas County Sheriff's Office):** Purpose-built bomb truck with equipment storage, x-ray capabilities, and robot transport functionality. Enhances the response to explosive threats and supports tactical operations.
- Small Platform Bomb Robots (Denver and Boulder Bomb Squads):** Two small platform robots for EOD and surveillance operations. Improves safety and efficiency in confined spaces during hazardous material operations and SWAT missions.
- Denver Advanced Team Leader CQB Training Course (Denver Police Department):** Advanced training for 20 team leaders to enhance coordination and de-escalation tactics. Available regionally for SWAT teams.
- Regional Cybersecurity Risk Assessments (NCR Member Agencies):** Third-party assessments including penetration testing and vulnerability analysis. Strengthens IT security and mitigates regional cyber risks.

- **Denver Access Control Optimization (Denver Elections Division):** Upgraded access control systems with advanced card readers. Bolsters physical security of election facilities to ensure integrity and reliability.
- **North Metro Regional Trauma Training (North Metro Fire Rescue District):** High-fidelity trauma simulation training for EMS, law enforcement, hospitals, and fire departments. Enhances response capabilities for MCI and CCTA scenarios.
- **JEFFCO EOD Response Vehicle (Jefferson County Sheriff's Office):** Specialized EOD response vehicle to improve regional capabilities for explosive threat mitigation. Ensures timely and efficient response to high-risk incidents.
- **Crime Lite Project (Adams County Sheriff's Office):** Crime-Lite Auto forensic systems for detecting and analyzing evidence. Improves evidence collection efficiency during crime and terrorist incidents.
- **Fatality Management Support (Denver, Douglas, and Boulder Regional Coroner Offices):** Litter gurneys, decontamination equipment, DNA testing materials, and secure communication devices. Enhances decedent recovery and management during mass fatality incidents.
- **Hazmat Technician Training (Boulder County Hazmat):** NFPA 470 training for regional Hazmat teams to maintain Type 1 response capabilities. Meets increasing demand for specialized hazmat personnel.
- **Crown Jewels Analysis Project (NCR Member Agencies):** Crown Jewels Analysis services for identifying critical assets and prioritizing cybersecurity efforts. Provides actionable insights for securing key systems.
- **Deployed DuoDote Kits (Arvada Fire Protection District and Regional Hazmat Teams):** 510 DuoDote kits for treating nerve agent and organophosphate exposure. Enhances responder safety during chemical or biological incidents.
