




Program Update - Procurement

Project Procurement

- CM/GC Enabling Construction Contract negotiated and signed by Kiewit
- CM/GC Peña Boulevard Bridge Proposals received; evaluation and negotiations ongoing
- Peña Boulevard Bridge Design Proposals received; evaluations and selection ongoing

Program Administration/Diversity Plan Compliance

- Document Control Task order executed, staff to start July 2010
- Administrative Services Subconsultant Agreement executed and staff on board
- Strategic Communications Negotiations completed;
 Subconsultant Agreement drafted, task order in preparation

Concept Design Status

- Upcoming presentation of design concept on Thursday,
 July 29, to select government, business and community
 leaders along with the media
- DIA employees to get a preview on July 28th
- Design to be displayed at a location in Jeppesen Terminal and will be accessible to the public



Kiewit CM/GC Contract

- Maximum contract value: \$50 Million
- Pre-construction task order: \$567,515
- Construction period: November 2010 August 2011
- M/WBE participation: 20%
- Job creation: Will create approximately 250 construction jobs
- Contract & Selection
 - RFP issued requesting pre-construction services fee and CM/GC Fee %
 - Three proposals received
 - Kiewit selection based 70% on proposal and 30% on fee
 - Individual construction packages to be bid separately



Scope of Enabling Packages

- Development of contractor staging/trailer area and parking for South Terminal Redevelopment Program
- Early excavation package including 450,000 cubic yards of soil
- Additional 400,000 cubic yards excavation package
- Relocation of T1 service road and associated utilities
- Terminal tent anchor modifications

Kiewit Services

Pre-Construction Services

- Estimating and scheduling
- Phasing and feasibility services
- Design coordination
- Permit applications
- Establishing a Guaranteed Maximum Price (GMP) for all the enabling packages

Construction Services

- Self-perform some work as General Contractor
- Bid remaining work
- Maximum contract amount: \$50 Million



Kiewit's Diversity Commitment

To meet or exceed the established goal of 20% M/WBE participation by utilizing focused approach:

- Offering *meaningful* opportunities
- Providing *mentoring*
- Developing a **technical assistance** and **training** program

M/WBE Outreach

- Create opportunities to inform M/WBE subcontractors and suppliers of subcontracting opportunities
- Use community services and organizations to assist in the recruitment of M/WBEs
- Reach out directly to individual M/WBE subcontractors and suppliers and encourage them to prequalify for work packages
- Initiate follow-up calls and emails to qualified subcontractors and suppliers
- Conduct one-on-one M/WBE subcontractor and supplier interviews

Assistance Approach

- Provide interested M/WBEs with complete information regarding plans, specifications and project requirements
- Assist in locating bonding, lines of credit, insurance, necessary equipment, supplies, materials or related assistance or services to aid M/WBE participation
- Communicate to non-selected firms so they may learn how to better propose on work
- Continue to partner and team with key M/WBE firms so we develop and nurture trusting and open relationships for our mutual benefit



Finance Update

- Kiewit services to be financed with General Airport Revenue Bonds (GARBs)
- Funds will be borrowed and encumbered as notice to proceed (NTP) orders are issued
- Currently assessing bond issuance this fall for some portion of projects, including Build America Bonds for the hotel
