## **EXECUTIVE SUMMARY**

Theatres & Arenas is requesting approval of a Promoter Commission Program agreement that will induce promoters to host events in T&A facilities (Red Rocks, Denver Coliseum, Boettcher Concert Hall, Buell Theatre and Ellie Caulkins Opera House). This agreement will share rental revenue with promoters of qualifying events assuming they meet certain minimum ticket sales and minimum event bookings in our venues. This practice has been in place at Red Rocks for several years and, because of past successes in this "rental incentive" that increases concession and other revenues, it is being expanded to all Theatres & Arenas' facilities.

Promoters will receive a percentage rent rebate for qualifying shows (based on paid attendance):

- o 40% of rent for one (1) through twenty (20) qualifying shows at RR;
- o 50% of rent for twenty-one (21) through thirty (30) qualifying shows at RR;
- o 60% of rent for thirty-one (31) and up qualifying shows at RR;
- 25% of rent for a minimum of five qualifying shows at DPAC;
- o 35% of rent for any show at the Coliseum

An event shall be considered a "qualifying event" if it meets the minimum required number of paid tickets as follows:

- Red Rocks 2.000 tickets
- Buell Theatre 750 tickets
- o Ellie Caulkins Opera House 750 tickets
- o Denver Coliseum 2,000 tickets
- Boettcher Concert Hall 750 tickets
