6 **For an ordinance approving a First Amendment to the Service Plans between the**  
7 **City and County of Denver and DUS Metropolitan District No. 1, DUS**  
8 **Metropolitan District No. 2, DUS Metropolitan District No. 3, DUS Metropolitan**  
9 **District No. 4 and DUS Metropolitan District No. 5.**

11 **WHEREAS**, the City and County of Denver (the “City”), Colorado (the “State”), originally  
12 approved the Service Plans for the creation of DUS Metropolitan District No. 1, DUS Metropolitan  
13 District No. 2, DUS Metropolitan District No. 3, DUS Metropolitan District No. 4 and DUS Metropolitan  
14 District No. 5 (“DUS Metropolitan District Nos. 1-5”) pursuant to Ordinance No. 399, Series of 2008  
15 on August 5, 2008; and

16 **WHEREAS**, the Boards of Directors of DUS Metropolitan District Nos. 1-5 desire to amend  
17 their respective Service Plans; and

18 **WHEREAS**, upon publication of notice, City Council held a public hearing regarding the First  
19 Amendments to the Service Plans for DUS Metropolitan District Nos. 1-5, on January 30, 2017.

20 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

21 **Section 1.** That upon consideration of the First Amendments to the Service Plans (and the  
22 conclusions contained therein) for DUS Metropolitan District Nos. 1-5 and other facts and  
23 information, including holding a duly noticed public hearing, the First Amendments to the Service  
24 Plans, available in the office and on the web page of City Council, and filed in the Office of the City  
25 Clerk of the City and County of Denver on the 19th day of January, 2017, Filing Nos. 08-724-I; 08-  
26 724-J, 08-724-K, 08-724-L and 08-724-M , respectively, are hereby approved.
