8 **For an ordinance approving and providing for the execution of a proposed**
9 **Intergovernmental Agreement between the City and County of Denver and the**
10 **Colorado Department of Transportation concerning the "Denver TSSIP-1"**
11 **project and the funding therefor.**

13 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
14 Intergovernmental Agreement;

15 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
16 **DENVER:**

17 **Section 1.** The proposed Intergovernmental Agreement between the Colorado Department of
18 Transportation and the City and County of Denver, a copy of which is duly filed with the City Clerk,
19 Filing No. 11-336, be and hereby is approved in all respects.

20 **Section 2.** The Mayor or his lawful successor and other proper officials of the City and
21 County of Denver, in its behalf, are hereby authorized and directed to execute said
22 Intergovernmental Agreement and the Clerk and Recorder of the City and County of Denver is
23 hereby authorized and directed to attest and impress the official seal of the City and County of
24 Denver on the Intergovernmental Agreement.

25 **Section 3.** The Mayor, his successor in office, or his duly authorized representatives, and
26 other officials of the City are hereby authorized and directed to do all things required to be done in
27 order to obtain payments under the Intergovernmental Agreement, including, but not limited to,
28 filing requests for payments, contracting with persons and organizations in order to carry out the
29 provisions of the Intergovernmental Agreement amendment, filing reports and keeping records
30 relating to fiscal and evaluation matters, and forwarding other materials to the Colorado
31 Department of Transportation.

32 **Section 4.** The payments made by the Colorado Department of Transportation to the City
33 pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of
34 the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18
35 of the Revised Municipal Code of the City and County of Denver.
